WHEREAS, the Council of the City of Knoxville, by Resolution R-120-2012, established the legislative internet forum as permitted by TENN. CODE ANN. § 8-44-109; and

WHEREAS, by that Resolution, the City of Knoxville agreed to host the forum on a City of Knoxville server; and

WHEREAS, technology has improved over time where it is now preferred by the City's Information Systems Department that the forum be hosted on an external server; and


WHEREAS, the Tennessee Office of Open Records Counsel has consented to the hosting of the forum on an external server.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF KNOXVILLE:


SECTION 1: The internet forum for the Council of the City of Knoxville is authorized to be hosted on an external server provided by a third party in a contractual relationship with the City of Knoxville. This server will be available at all times other than as necessary for technical maintenance or unforeseen technical limitations. It is estimated that the server will be available over 98% of the time.

SECTION 2: The City of Knoxville Information Systems Department shall monitor the forum to ensure that it functions properly, but will not delete or edit any comment posted.

SECTION 3: This Resolution shall take effect from and after its passage, the welfare of the City requiring it.
